The Denham Springs Christmas Parade Rules

- 1. **No Santas permitted.** There will be only one Santa in the parade.
- 2. No float will be allowed to enter from Range Ave onto Yellow Jacket Blvd.

 ALL floats MUST enter from Hatchell Ln to Maple St. to Yellow Jacket

 Blvd. NO exceptions.
- 3. A "Release and Hold Harmless Agreement" must be signed. Include the names of all riders and/or walkers. (All minors must have a parent/guardian sign the release.) This can be delivered to the registration booth the day of the parade.
- 4. Applicants must check in at the registration booth that will be located under the overhang, right next to the concessions stand in front of the old Freshman High gym and receive a participant voucher to be displayed on your float, you must sign in before 1:00 pm. At the registration booth you will be asked to provide a copy of a valid driver license (for the person driving the float) and proof of vehicle insurance.
- 5. Submit the entry fee payable by check to: Denham Springs Kiwanis. **DO NOT SEND CASH**. Payment is due by December 9, 2025 or you will be subject to a \$25 late fee. You can mail payments or drop off to any First Guaranty Bank in Livingston Parish. (Parade fees are non-refundable)
- 6. The tow vehicle for your float must be attached to the float when your float arrives and remain attached for the duration of the parade.
- 7. A minimum number of walkers are required, please see the application for walkers required for each category and the walkers must remain during the entire parade route as protection for your group and vehicle/float, and to prevent injury to people lining the streets. Minimum age requirement for a walker is 16 years old.
- 8. **All walkers will be required to wear brightly colored safety vests**. Vests must be provided by each walker and/or float.
- 9. Any float without the required walkers will not be permitted to participate.
- 10. You (or an authorized representative of your entry) and the float driver **must** attend a mandatory safety meeting at 1:00 pm in front of the old Freshman High flagpole and will be conducted by the DS Police Department on parade day.

- 11. No animals allowed unless they are inside the vehicle.
- 12. Maximum height of floats is 12 feet.
- 13. No alcoholic beverages are permitted. No vulgarity will be permitted. Participants and entries in the parade are not allowed to have or be under the influence of alcohol or drugs.
- 14. Music volume may be required to be turned down if it interferes with other floats or participants. This is at the discretion of the parade officials. Because this is a family event we require music type to be family oriented only, no vulgarity or obscenity allowed.
- 15. Standard throws only. No damaging materials, projectiles, or profane materials will be permitted.
- 16. Parade participants are required to provide throws for the parade. All participants MUST have their throws on the float prior to arriving.
- 17. In the event of inclement weather or anything beyond Kiwanis' control on the day of the parade, the parade will be held on an alternate date PENDING APPROVAL. If you are unable to participate on the alternative date, Kiwanis thanks you for your donation. Kids need Kiwanis.
- 18. Parade officials reserve the right to remove your entry from this parade for not abiding by the rules outlined above.
